Adoption of CO Recommended Academic Preparation strategies for AY 2020-21

The chancellor's office sent out a document over the summer with recommendations for how to move forward on the graduation initiative given Covid.

- **CO Recommendations:** Develop a plan to provide academic and non-academic virtual support for first-time students who arrive in need of additional academic preparation.
 - i. Promote closer collaboration between the divisions of Academic Affairs and Student Affairs to provide more intensive individualized support for first-year students placed in Category III and IV and enrolled in supported courses.
 - a. This is what is being done with the Forerunners Program, we are peer mentoring for the category III and IV students.

- ii. Develop innovative opportunities for enriching the curriculum through web-based supplemental instruction, tutoring, and/or peer mentoring.
 - a. J. Whitaker will create a paragraph stating how we are already developing innovative opportunities.
- iii. Provide targeted professional development for faculty who will teach introductory mathematics/quantitative reasoning and written composition, highlighting proven virtual pedagogical practices that enhance student support and foster self-regulated learning.
 - a. A series of workshops were designed by three faculty in the Mathematics Department, Dr. Aubrey Kemp, Dr. Eduardo Montoya, and Dr. Becky Larson. The workshops were offered to instructors teaching first-year quantitative reasoning courses. All instructors participated in the first session, for the second session, instructors divided into three groups, each focused on ensuring consistent pedagogy across instructors teaching mathematics education, statistics, or pre-calculus courses.
 - b. K. Flachmann will provide information on what she did in First-year written communication instruction in Professional Development for instructors.
- iv. Provide professional development to encourage faculty and staff to provide supplemental instruction and related academic support services through virtual modalities to promote sustained student engagement.
 - a. J. Whitaker will write a couple of sentences to describe what they're doing with supplements instruction in the SSE tutoring center.
- v. Expand outreach and support to help students navigate the shift to virtual learning modalities accounting for each student's preferred learning style.
 - **a.** A series of videos aimed at supporting CSUB students during the virtual delivery of instruction is being produced through a collaboration between the Faculty Teaching and Learning Center and Marketing and Communications.

Summer 2021 Financial Aid Preliminary Plan

D. Jackson submitted a proposal for \$975 thousand from the Chancellor's Office to offer A2 and B4 courses for students who have completed their first two semesters, but not completed those requirements. This money has to be used for financial aid and it has to be a stateside course.
