Each employee is entitled to one Personal Holiday, which must be taken on one day during the **2024** calendar year. If the employee fails to take the Personal Holiday before the end of the year, the holiday is forfeited.

- Lincoln's Birthday is observed Monday, February 12, 2024; the holiday credit will be observed Friday, November 29, 2024.
- President's Day is Monday, February 19, 2024; however, classes are in session on this date, and therefore, the holiday credit will be observed on Thursday, December 26, 2024.
- Admission Day is observed Monday, September 9, 2024; the holiday credit will be observed on Friday, December 27, 2024.
- Indigenous Peoples' Day is observed Monday, October 14, 2024; however, classes are in session on this date, and therefore, the holiday credit will be observed on Monday, December 30, 2024.

\*Please note that Tuesday, December 31<sup>st</sup> is not a covered holiday. You may use vacation, Compensatory Time Off (CTO) or your personal holiday to cover this day.
