



# Affidavit of Financial Support Form for Graduate Programs

Applicants holding or requiring F-1 Student immigration status are required to provide appropriate documentation of financial support before a form I-20 can be issued.

As nonresident alien students are not eligible for financial aid, they must demonstrate sufficient funds to support themselves. If the student intends to use personal funds, they must submit financial statements verifying at least \$34,000 in liquid assets. Bank statements and financial affidavits must be dated within the last 6 months.

If a private sponsor (such as a family member, friend, home government, or private institution) will provide financial support, the sponsor must sign the Statement of Financial Obligation below. Additionally, the sponsor must submit an official bank statement verifying at least \$34,000 in liquid assets. Bank statements and financial affidavits must be dated within the last 6 months.
