## Supplier 360 Tab

The **Supplier 360** tab shows the following information:

1. The supplier's legal name, Doing Business As (DBA) name, supplier ID number, and registration status display at the left side of the screen. Note that suppliers can be searched in the Supplier Search by both their legal name and their DBA.
2. Active/inactive status displays further toward the center of the screen, under Supplier Details.

4. **NAICS Codes** and **Commodity Codes** are shown at the right side of the screen. NAICS codes are general classifications that describe the supplier’s industry or business sector; commodity codes are more specific codes for the various products and services offered by the supplier.

Note that NAICS codes and commodity codes are useful for differentiating between suppliers with similar names, as shown below with Dell and Dell Financial Services LLC. You can also scroll down to the bottom of the Supplier Details box to view the supplier’s **Business Description** (short description of the supplier and/or the services they offer), as shown on the next page.


