- i. Faculty Success initiatives:
 - i. Questions for Interim Provost Rodriguez regarding the new Provost Faculty Advisors for Strategic initiatives roles and the DEI Faculty Fellows Program. Interim Provost Rodriguez: Provided clarification regarding the differences between these roles and initiatives. The Provost Faculty Advisors for Strategic Initiatives will be focused on faculty success, such as professional development for department chairs, retention of faculty, and experience for the cluster-higher faculty as they enter their second year.
- ii. Enrollment:

i. Dr. Dwayne Cantrell, AVP for Enrollment Management: "Just for clarification on enrollment at CSUB, we are headed in a positive direction and our enrollment numbers are better than the previous two years, however our FTES is still below our funded target."

ii. Discussion:

- 1. Interim Provost Rodriguez provided clarification regarding the current trends. Enrollment is based on headcount (how many students) and FTES (Full-time equivalent students). FTES is the indicator used by the CSU Chancellor's Office to allocate funding. Census Day is September 23.
- 2. Question posed regarding how the CSU Chancellor's Office set the targets for the university. Interim Provost Rodriguez: The rationale behind these targets is usually imbedded in the enrollment history of the campus. He will research and share the information once it is available.
- 3. Future transparency requested for when faculty lines are opened for hiring and when others are continued to be captured.
