- Referral #7 Advising Taskforce Recommendations
  - Consensus that the work professional advisors do is important, necessary and an integral part of the operation of each school. Mentioned several times that the main factor needed for success is resources to support the

advisors, more advisors to reduce the advisor to student ratio in some schools and common tools across all advising activities to support the goal of a consistent experience.

- The various advising centers have been built over several years to create a working environment that is unique to each school and is performing well for their respective areas. It is feared that the restructuring of the reporting responsibilities proposed by Option #1 of the recommendation threatens those connections and working relationships. The new Director of Admissions would need authority to implement changes and without direct reporting from professional advisors would leave them without sufficient power to effect those changes.
- Our discussion for this session included representation from Professional Advisors (4 schools), and a faculty member who participated in the early draft of the recommendations. The benefits of Option #2 were highlighted. The next meeting will provide an opportunity for Option #1 to be discussed. Invitations to attend the meeting will be provided. If conflicts arise, a written statement will be requested.
