

# Standard Financial Reporting

- How can I figure out my balance available for my stateside and non-stateside funds?

## WHY STANDARD FINANCIAL REPORTS

Standard Financial Report aims to simplify reporting to reduce time and confusion. It will help to increase understanding of the report data, which will increase the report data credibility. Lastly, it ensures we are looking at the same numbers, which can facilitate conversations with Accounting, Fund Managers, and Budget Analysts.

## 5 STANDARD REPORTS

The standard reports consist of reports that appropriate for stateside and non-stateside funds.

#	Report	Fund Type
1	Standard Operating Report	Stateside
2	Standard Fund Balance to Date Report	Non-Stateside
3	Standard Open POs Report	Any
4	Standard Actuals Transactions Report	Any

## CONCEPT REFRESHER

### Golden 6

When running stateside reports, you will use the Golden 6 in the report filters. The Golden 6 consists of the following information:

- Business Unit
- Fiscal Year
- Fiscal Period
- Fund
- Department
- Not Account Category = 603

### Data Warehouse Math

To assist you with determining whether an item gives reason for concern, you can use the Data Warehouse Math equation to test the information.

*Balance Available =*

$$\text{Current Budget} - \text{Actuals} - \text{Encumbrances}$$

If the Current Budget is blank, the the Balance Available is just the sum of the transactions that hit the FDW and not your true Balance Available.

## SAVING CUSTOMIZATIONS

When you run a report in the FDW, essentially you are customizing an existing report. You can save your customizations to reports using the Page Options button.

- Click Page Options
- Click Save Current Customization
- In the Name box, give your report a name
- Click OK

## APPLYING SAVED CUSTOMIZATIONS

Customizations are saved to the report. As such, you will need to navigate to the desired report before applying your saved customization.

- Navigate to your desired report
- Click Page Options
- Click Apply Saved Customizations
- Click the desired customization

## 1. STANDARD OPERATING REPORT

The Standard Operating Report provides a summary of your financial status. The report is appropriate for stateside funds, such as BKXXX and BKCXX funds, only. It shows your original budget, current budget, actuals, encumbrances, and balance available. Additionally, this report does not show any transactions related to Benefits.

### How to Read this Report

This report is read left to right, beginning with the Grand Total row.

- Find the Grand Total row.
- If the Current Balance is 0, then do not go by the Balance Available
- If the Current Balance is not 0, then the Balance Available is current based on the transactions that have been processed.

## 2. STANDARD BALANCE TO DATE REPORT

The Standard Fund Balance to Date Report provides a summary of financial status for a non-stateside fund. The report is appropriate for non-stateside funds, such as MXXXX funds, only. It shows your current budget, actuals, encumbrances, and balance available. Additionally, it is designed to all activity for the fund. As such, this report includes any prior balances, continuous appropriations, or other related transactions.

### How to Read this Report

This report is read top to bottom and left to right

#### 1. Revenues

- In the Revenues section, find the Revenues Total row.
- If the Current Balance is 0, then reverse the sign for the Balance Available
- If the Current Balance is not 0, then the sign on the Balance Available is correct based on the transactions that have been processed

#### 2. Expenses

- In the Expenses section, find the Revenues Total row.

- If the Current Balance is 0, then reverse the sign for the Balance Available
  - If the Current Balance is not 0, then the sign on the Balance Available is correct based on the transactions that have been processed
3. Subtract the Expenses Total from the Revenues Total

### **3. STANDARD OPEN PURCHASE ORDERS REPORT**

The Standard Open POs Report provides a summary of your open purchase orders. The report is appropriate for state-side funds, such as BKXXX and BKCXX funds, only. It shows your purchase order number, vendor name, and other purchase order information.

#### **How to Read this Report**

This report is read left to right

- Select the appropriate Supplier from the drop-down menu
- Click the Purchase Order link
- The detail shows all the activity related to the purchase order including encumbrances and vouchers.

#### **How to run this report**

To run this report, click the following:

Home > Dashboards > Transaction Inquiry > Open PO Reports > Open PO Views > Page Options > Apply Saved Customizations > \_\_\_\_\_

Use the Report views to see Open POs by fund, department, or supplier. If you use the Open POs by Supplier, use the Supplier Sdescr dropdown to select the desired supplier.

### **4. STANDARD ACTUALS TRANSACTIONS REPORT**

The Standard Actual Transactions Report is designed for downloading your transactions to Excel. It provides the detail transactions associated with your stateside funds, such as BKXXX and BKCXX funds, only. Additionally, this report does not include any Benefits related transactions.

#### **How to Read this Report**

This report is read left to right. Each row contains information regarding the transaction.

#### **How to run this report**

To run this report, click the following:

Home > Dashboards > Transaction Inquiry > Actuals Reports > Actuals Transactions > Page Options > Apply Saved Customizations > \_\_\_\_\_

After running the report, click Export > Excel > Excel 2007+ > Open
